

In addition, as occurred in the last election, just before the filing deadline, loyal soldiers Pat Francis, Kevin Burke and William Statom filed as "write-in" candidates, so the August 20 primary is now considered "closed" to all primary voters except registered Republicans.

Samantha Scott, Chairman of the Sumter County Republican Party, expressed her gratitude to the write-in candidates in a Letter to the Editor published in *Villages-News.com*, stating that the Party is "protecting the integrity of the Republican Primary Election by adopting the policy of facilitating write-in candidates to lawfully preserve the right of Republicans to choose our Party's nominee without interference."

She accused Democrats of trying to crash the Republican Party Primary.

It seems that Ms. Scott and the Sumter County Republican Party have no qualms about eliminating the other 20,000+ voters who are registered to vote with no party affiliation. According to the Sumter County Supervisor of Elections web page there are 71,338 registered Republicans, 24,304 Democrats and 26,989 "Others." Republicans have an overwhelming majority of registered voters at 58%. So, what are they so afraid of? Perhaps that independent thinking voters might just decide they'd rather back other Republican candidates that have not sold out to the Developer?

Voters are reminded that they have until July 22, to register to vote or update/change their party affiliation in order to ensure voting in the August 20 primary. Early voting begins August 10.



Write-In Candidate Loophole Closes Commissioners' Primary

How Independents and Other Party Affiliations Can Vote

Here we go again. Write-in Candidates have once again filed bogus intentions to run for Sumter County Commissioner. This move by the Sumter County Republican Party once more attempts to shut out independent voters and those with other party affiliations. FL is supposed to be an open primary state when all candidates running in an election are from one party. Republicans used this same tactic in the 2020 election, hoping to win the primaries so independents and other party affiliated voters could not vote. However, thousands of Villages' registered voters changed their party affiliation so they could vote and defeated the Developer puppets by a 3-1 margin.

Republican Party Chair Samantha Scott defended this action by saying they are trying to protect the "integrity" of the Republican Primary. She blamed the Democrats for trying to "crash" their primary. Democratic Party Chair, Bob Berg, fired back, saying Republicans used the write-in loophole to extend voter suppression to these races. The League of Women Voters also said that while apparently legal, the move "flouts the intent of the Universal Primary Amendment," and asks, "is it right?"

Florida decided it would be an open primary state when voters amended the State Constitution in 1997 by passing the Universal Primary Amendment (UPA) that said primaries must be open to all voters if the winner of the primary will face no opposition in the general election. When candidates from only one party are running, the primary election is the de facto general election.

In 2000, then-Secretary of State Katherine Harris wrote in an opinion that write-in candidates,

registered as members of the party that isn't fielding a candidate, can close the primary. Florida courts have refused to get involved. Her finding continues to allow manipulation of Florida's elections.

If there is a write-in candidate, independents and members of the parties not fielding candidates are shut out of the primary.

SECO Pole Maintenance Rates for The Villages Districts to Skyrocket with No Warning

Supervisors and District Staff were shocked and angry when they were given the news that SECO Energy was raising light pole maintenance costs by a whopping \$15 million. Some districts may see increases in the hundreds of thousands of dollars.

Supervisors and staff met with SECO executives in a closed meeting to get some answers.

SECO apparently stated that for years light pole maintenance has been subsidized by the entire membership as the current light pole maintenance tariff only covered approximately \$13MM of the current expense of \$28MM. A rate study was engaged by SECO to propose a rate increase for pole maintenance. This increase was approved by SECO Board which would increase the revenue by \$15MM to provide revenue from light pole maintenance that would support this specific need and not be supplemented by other rate payers. The extra \$15MM that was coming for all rate payers will now be able to pay for deferred maintenance projects and vegetation maintenance.

Communication was an issue that was discussed as well, and supervisors asked that SECO spread out the cost over a few years. The SECO CEO was asked to continue discussions with District staff to seek some type of resolution to the roll out of the additional funding of light pole maintenance.

What is SECO and How is it Different than **For-Profit Energy Companies?**

co-op in Florida and the seventh largest in the nation out of more than 900 electric cooperatives.

SECO boasted financial strength in its 2021 **Annual Report:**

Operating Revenue: \$430,075,641

Net Margins: \$24,341,261 Total Assets: \$961,706,562

Cooperatives are owned by the members who use its services. When you apply for service with SECO Energy, you become a member-owner. SECO is a not-for-profit electric cooperative, as such, we generally have an excess of revenues over expenses. This excess, called Capital Credits, is allocated annually to members based on their energy purchases during the year.

According to its website SECO states, "Through sound financial stewardship, SECO Energy has returned (retired) Capital Credits to members consistently for many years. The most recent retirement is \$2.01 million that was approved by the Board of Trustees in their September 2023 meeting. The co-op has retired over \$45 million in Capital Credits in the last decade and \$80 million to its current and former members since its inception."

The president of the SECO Board of Trustees is Gerald Anderson, a Villages resident. Residents often overlook requests from SECO to attend board meetings or vote for people to serve on the Board. It appears this is another Board the POA will need to watch for unexpected cost impacts for residents. For now, SECO's Board has said residential rates will not be impacted. However, it will be conducting a rate study in 2025.

In a follow-up communication to The District, the Board of Trustees said it has approved a resubmittal to the FPSC to request a two-year phased approach to incorporate the pole rental rate increase. With FPSC approval, SECO will reduce the approved pole rental fee increase by 50%, effective October 1, 2024. In the second year, effective October 1, 2025, SECO will adopt the full pole rental increase fee that was previously approved. Before final Board of Trustees' adoption, this rate revision must be approved by the FPSC.

In Case You Missed It...Highlights from June Meetings

PWAC Members Surprised by Video

Project Wide Advisory Committee (PWAC) members expressed surprise over a video describing in detail the proposed rebuild plans for the landing at Lake Sumter. The video came out the afternoon PWAC members had been presented with the project that same morning. It was obvious to the committee members that the project had already been in the works since the slick video was ready to go.

This is not the first time that PWAC members have had a Villages project foisted on them. Two years ago, they were informed of the need to replace the water tower and windmill at the Brownwood Square. This time, the strategy was to develop Lake Sumter landing into an amenity instead of keeping it on "Exhibit A" for maintenance. The late POA Board and Community Development District (CDD) 8 Supervisor, Sal Torname, often took issue

with the items on "Exhibit A" because they were more often than not aesthetics that The Villages used as marketing tools rather than an actual service to residents.

At the May meeting when the project, priced in the neighborhood of \$3 million, was presented to PWAC, they asked if the Developer would participate in the funding. Assistant District Manager, Bruce Brown, said the communication was forwarded to the Developer, but as is typical, there was no response.


No Go on Priority Pools

After push back from Priority Pool members, and a price tag of nearly \$250,000 to the Amenity Authority Committee (AAC), the Developer withdrew his "offer" to allow Village residents without membership to use the country club pools north of CR 466 while Paradise Recreation Center is being rebuilt.

First Responders Recreation Center Causing Issues for Neighbors

AAC members were told at the July meeting that the light at the gate at the First Responders Recreation Center is disturbing about four homes behind the Center and there are drainage issues in backyards that they didn't have before the construction. Neighbors hoped that once construction was complete these issues would go away, but they have not. Deputy District Manager Carrie Duckett said staff would check into the issues and they will be placed on the "Old Business" list for the next month's agenda.

Lightning Safety In The Villages by Len Hathaway

Editor's Note: Len Hathaway made his 12th annual presentation to the POA General Membership Meeting in June at Laurel Manor Regional Recreation Center, with his colleagues Scott Jones a retired firefighter, and John Reformato, a retired electrical engineer. Also present were representatives from SECO Energy displaying their surge equipment and Danny Mack from A-1 Lightning Protection Services, Inc. At the conclusion of the meeting there was a raffle for a lightning protection system.

As a resident of The Villages, you need to be aware of the risk that lightning poses to you, your family, your pets, and your property and what you can do about it. Florida typically leads the nation each year in fatalities, injuries, and property damage. All thunderstorms produce lightning that can be highly dangerous and unpredictable. Our area averages 108 thunderstorm days per year. Therefore, residents need to consider the more frequent but less severe indirect lightning strikes and the less frequent but more severe direct lighting strikes.

To focus attention on lightning safety the National Lightning Safety Council (NLSC) conducts an annual campaign called Lightning Safety Awareness Week. This year the dates were June 23-29, in advance of the summer lightning season across the country.

Lightning Awareness – Plan Ahead

The NLSC's lightning awareness campaign is focused on planning ahead to avoid being caught in a dangerous situation.

- Listen to the local weather forecast
- Plan ahead and know where to go for
- Consider a cell phone app that gives weather including lightning
- Act early so that you can quickly get to shelter
- WHEN THUNDER ROARS, GO INDOORS!

Places that are not safe include trees, golf courses, fences, dugouts, lakes, swimming pools, picnic areas, pickleball courts, tennis

courts, softball fields, open fields, flag poles, picnic shelters, fishing, light poles, bleachers, dog parks, nature trails, etc. Remember lightning is not only dangerous but highly UNPREDICTABLE and does not always strike the tallest object in your area.

A hard topped all metal vehicle also qualifies as safe refuge from lightning provided that the windows are closed, and you are not touching any metal parts in the vehicle. Golf carts, motorcycles, convertibles, and bicycles are not safe during a thunderstorm.

While no place is entirely safe from lightning you should seek shelter in a substantial building which can be your own home. Even when you are in your home (or substantial building) you are not entirely safe from lightning and should avoid:

- Plumbing including taking a shower during a thunderstorm
- Electrical equipment and appliances
- Corded telephones unless of course there is an emergency - (cell and portable telephones are not wire-connected telephones)
- Windows

After the storm passes

An integral part of the National Weather Service's awareness campaign, WHEN THUNDER ROARS, GO INDOORS, is to wait 30 minutes after the last sight of lightning or rumble of thunder. Lightning has been known to strike outside of the rain area (as was the case when a 12-year-old was struck in 2017 at the Polo Fields) from up to ten miles away. In some cases, this has occurred even after the clouds have departed and the sun has come out. This is sometimes referred to as "a strike from the blue."

Indirect lightning strikes

Electronics and appliances can be damaged due to lightning induced surges into the wiring system in your home.

An Indirect lightning strike may not strike your home but may strike nearby trees, flag poles, a neighbors' home, or some unknown location. These are more common but usually less severe than a direct lightning strike discussed in the next section.

Lightning-induced surges can damage

control boards and computer chips, which are susceptible to even a relatively minor surge. Remember – Lightning Loves Technology!

To protect against damage to your sensitive electronic equipment such as computers, televisions, microwave ovens, telephone answering machines, games, refrigerators, garage door operators, irrigation controllers, motorized recliners/sofas, cell phones, and while charging golf carts and electric vehicles you may wish to consider both primary and secondary surge protection.

Primary Surge Protection

This is surge protection installed on your electric meter by your electric utility. For example, if you are a SECO Energy customer they will lease a surge protector on your electric meter for \$5.95 per month or purchase it for \$349 for 200-amp service (\$399 for 320-amp service). Duke Energy and Leesburg Electric also have similar lease agreements. It can also be achieved by engaging a licensed electrician to install a surge protector on a dedicated two-pole breaker on your electrical panel. This level of protection is to prevent surge damage to hard-wired equipment that you do not plug into a 120-volt or 240-volt circuit. In John Reformato's presentation on this subject he discussed layers of protection, as you may wish to consider doing both. This is not "whole house" surge protection!

Secondary Surge Protection

This level of surge protection is called pointof-use (POU) and the devices are sometimes
referred to as "plug ins." These surge
protectors plug into a 120-volt wall outlet
to protect microwave ovens, garage door
openers, and refrigerators. Underwriters
Laboratories listed surge protectors are
another form of secondary surge protection
for televisions and computers. These devices
can be purchased from electronics, hardware,
big box stores, and the internet. Surges can
also enter your home from other sources such
as telephone and satellite/cable TV lines.

Therefore, it is vitally important that telephone lines to an answering machine or computer be routed through a secondary surge protector. This is also true for the coaxial cable line for a television.

Lightning Protection for Your Home Due to A Direct Lightning Strike

A direct lightning strike does not happen very often, but it can cause substantial structural damage with the ensuing fire. The chance that your home will be struck is very low, but it is not zero and is greater than winning the lottery. A total of 23 homes have been struck and destroyed since 2004 and none had lightning protection.

Only you, the homeowner, can decide if you need a lightning protection system commonly called lightning rods. One way to think about

it is assessing your own tolerance for risk. For example, if you have a high tolerance for risk you choose to do nothing, the odds are with you, the money stays in your pocket, and if the worst does happen you rely on your homeowner's insurance policy.

On the other hand, if you have a low tolerance for risk and wish to seek peace of mind to avoid the loss of your home, possessions, pets, vehicles, possible loss of life and the stress of the entire ordeal to reconstruct and live-in temporary quarters you may wish to consider a lightning protection system. Contrary to popular myth they do not attract lightning but simply give it a safe path to ground.

If you do choose to install a lightning protection system, be advised that there is no local, state, or federal oversight for residential properties and this can be a buyer beware

marketplace. Many lightning protection system installers police themselves by becoming listed by Underwriters Laboratories and employing installers who have passed a minimum of four exams to qualify as a Master Installer by the Lightning Protection Institute. Door-to-door solicitors not only violate our covenants, nor will they meet the qualification criteria. This may also be true for some firms listed in the telephone books or on the internet.

Do not be misled by a potential installer telling you that all equipment used is UL listed. Although this may be true it does not mean that the system to be installed will meet nationally recognized standards. Further, before any job is started the underground utilities should be marked by calling 811.

The 2007 corrugated stainless steel tubing (CSST) class action lawsuit was discussed. At that time the court found that CSST gas pipe posed an "unreasonable risk of fire due to lightning strikes" If this is a concern consider the benefits of a lightning protection system.



The above is the current state-of-the art, but safety is never absolute. It should be recognized that anything man-made can fail but the systems and equipment discussed above do function as designed a very high percentage of the time. As a homeowner, you should conduct your own due diligence for your lightning risk.



POA 2024 Watch List

Each year the POA Board of Directors creates a watch list of issues that it thinks will be important to residential property owners. Periodically, there will be updates on the issues, and usually at least one general membership meeting program will be dedicated to the topic. Following is the list for 2024, which will be summarized. For the full description of each issue see the January 2024 Bulletin online.



Villages Public Safety **Department Dependent District (VPSDDD)**

Last fall after the Sumter County Commissioners failed to raise the Fire Assessment Fee to fully fund the Sumter County Fire Department and Villages Fire Department, the Commissioners passed an ordinance allowing The Villages to create the Villages Public Safety Department Dependent District (VPSDDD). Commissioners selected a board of five Villages residents, who have worked over the last several months to study the funding needs of the Villages Fire Department.

The VPSDDD Board engaged a consulting firm to study a rate structure that would fund the department. The last proposal that the Board voted on, based on a preliminary assessment roll from the Sumter County Assessor's office, suggests a "readiness" rate of \$239 per taxable parcel, along with an \$81 demand fee based on the Equivalent Residential Unit (ERU) of 1,710 square feet. This helps to equalize the fee with nonresidential properties and represents, in the POA's opinion, a more fair system.

The only issue the POA has had is the lack of using a Fire Impact Fee to build new stations and equip them.





Elections

The primary elections for local offices will be coming in August. This Bulletin issue covers specifically the races for Sumter

County Commissioner. As stated in the articles, Developer cronies have donated hundreds of thousands of dollars to their recruited candidates. The Sumter County Republican Party also had write-in candidates file so the primary would be closed to all but registered Republicans. See the story on page 9.

Elections will be held for residential Community Development District (CDD) Board of Supervisors positions, and a landowner election will be conducted separately for three seats on the Amenity Authority Committee (AAC), which oversees amenities north of CR 466.



Morse Blvd Safety Improvements

The POA continues to monitor progress in making Morse Boulevard north of CR 466 safer

for golf cart traffic that runs in lanes next to the roadway, with no barrier. Residents said a simple fix, rather than the \$15 million + that was suggested in an engineering study, is to simply slow traffic down.

The Sumter County Sheriff's Department received a grant that allowed it to put extra speed patrols in that area, and by all accounts it has helped tremendously.



UF/The Villages Hospital

Quality of care at the UFHealth/ The Villages Hospital will always be a priority for residents in The Villages. The Center for Medicare

and Medicaid Services (CMS) released 2022 quality ratings in November and The Villages Hospital remained a 2-star facility based on several factors. Patient survey results gave the hospital only one star.

A presentation by Chief Clinical Officer Cheryl Chestnutt to the POA membership in February continues to demonstrate progress in the right direction, with many additional improvements already in place or in process.



Property Insurance

Property insurance will also continue to be a concern for Villagers, with several large companies ceasing to write

policies in Florida or setting stricter requirements. Fortunately, there was only one major hurricane in 2023, and lawsuits seem to be on the decline from the fraudulent business practices of some roofing contractors.

The POA will continue to watch for any developments from the State Legislature that may positively impact insurance rates in the state. Residents are encouraged to shop around at renewal time and have inspections done that may help make the case that your roof is in good condition.



Can You Spot a Scam? Here is What to Look For.

SENIORS VS CRIME

Our friends at Wells Fargo published an article on scam spotting and how to help your family and friends avoid scams and, with the proliferation of scam complaints we hear about, the message bears repeating. Our safety starts with awareness and here are a few consistent red flags you can look out for to stop scammers in their tracks.

- 1. Unexpected contact: A person or company contacts you out of the blue by phone, text, or email about an invoice, order, delivery, or a charge you didn't know about.
- 2. Everything is URGENT: Scammers will create a false sense of urgency and use pressure tactics like rude or pushy language to get you to act immediately.
- 3. Very specific or unusual ways to pay: Someone is asking you to send money using gift cards (ALWAYS a scam), cryptocurrency, a payment app or even an online wire to pay for something, resolve an "issue", get sweepstakes "winnings" or secure a high return on your "investment."
- 4. Threatening language: Scammers may tell you that you owe money and then threaten to call the police if you don't pay immediately. They may also coach you on what to tell the bank to withdraw or transfer money or tell you to keep a secret.
- **5.** The romantic "emergency": A new online love interest bombards you with "sweet talk" but doesn't seem to want to meet in person. Suddenly a hardship emergency strikes, and they want you to send them money.

What To Do If You Suspect a Scam:

- 1. **Slow down** pause and take a breath. Think it through.
- 2. Someone YOU DON"T KNOW is asking you for your money.
- 3. Remember it's YOUR money and you have the right to confirm things no matter how urgent anyone says it is. You are in charge when it comes to your money!
- 4. Contact the company they claim to be but don't use a phone number they supply look up the real number on the internet. Call your bank using a number you get from their website and not any number provided by the caller.
- 5. Consult with a trusted friend or family member before you take any steps to send money.

If you need help with this or any other type of suspected scam, you can call any of the four Seniors vs. Crime offices in The Villages. You can also request a speaker for your group or volunteer for Seniors vs. Crime by going to our website – **seniorsvscrime.com**. All our services are free of charge and any money we get back goes back to you.
